Dear Insurance Commissioner - Julie Benafield Bowman:

This letter will serve as written notice that Robert G. Meilander, Vice President and Corporate Actuary of The Northwestern Mutual Life Insurance Company (the "Company"), has been appointed by the Board of Trustees of the Company to be the Company's "appointed actuary," effective November 1, 2008, for purposes of applicable actuarial opinion and memorandum laws and regulations. This action was taken by the Board of Trustees at its September 24, 2008 meeting.

Mr. Meilander meets the requirements for a "qualified actuary" as set forth in such laws and regulations. He will replace Senior Vice President and Chief Actuary William C. Koenig, who will change roles in the Company as part of normal succession planning; he will take on the title of Senior Vice President – Government Relations Actuary effective November 1, 2008. Mr. Koenig has announced plans to retire in July 2009 after a career of almost 40 years at the Company.
