

Your Basic Guide to Medicare Coverage Options:

If you're turning 65 and are concerned about Medicare coverage, we can help. For most people the options for Medicare coverage come down to a few simple points:

- Most people turning 65 sign up for Medicare – and most people need to select Part D prescription drug coverage. There may be penalties for not selecting Part D coverage when you're first eligible.
