Dear Sir or Madam:

Group Vision Policy NVIGRP 5/07, and its corresponding Certificate were previously approved by your Department on August 16, 2007.

We have the opportunity to issue the Group Policy to participating Nursing Home Facilities in your state, in order to provide vision insurance benefits to their residents. We would like your request to consider this an eligible group under §23-86-160(5).

The Nursing Home Facility will, in essence, take the role of an employer in a traditional group. The program will work as follows:

Any resident of a participating Nursing Home Facility in the state of Arkansas is an eligible member.

Each resident (or legal guardian) will submit a completed and signed enrollment form in order to elect coverage. The enrollment form will include a summary of benefits, premium and legal guardian information as well as the usual member information.

The Facility will receive a monthly list bill, and will remit premiums for Medicaid and Total Vendor residents. Private pay residents will submit premiums individually.

Vision care benefits are available to each enrolled resident once every twelve (12) months, with a \$0 co-payment. A participating provider will travel to the Facility at regular intervals and provide covered services at the Facility. Services include:

- Comprehensive eye exam, including refraction
- Intermediate eye exam, including refraction
- Retinal or external photos
- \$75 retail value eyeglass frame

- One pair standard eyeglass lenses, (single vision, lined bifocals, or lined trifocals).

The participating provider will verify the resident's eligibility for benefits prior to services being provided. The participating provider will submit claims to Superior Vision Services, Ind., the Third Party Administrator, for covered services.

Superior Vision Services will process and pay claims to the provider in accordance with the contracted rates.

Your acceptance of this type of group, as being eligible for the issuance of a group vision policy would be greatly appreciated.
