This contract page is being submitted for your consideration and approval. It is new and when approved will replace the page 8 previously approved by your Department contained within form 05060. The replacement page when approved will be used with all new issues of form 05060 which is a Private Placement Variable Annuity contract.

No part of this filing contains any unusual or possibly controversial items from normal company or industry standards.

The Separate Account provision on page 8 of the approved variable annuity contract identifies the separate account as Separate Account 102. We now have an opportunity to use the contract with additional separate accounts of the Company, and as a result we would like to obtain your Department's approval to do so. The Separate Account provision on the revised page 8 has been rewritten so that the applicable Separate Account will be named on the Schedule Page.

Separate Account 102 is set up to accommodate SEC Investment Act 3(c)(7) type of clients who own investments of at least \$5,000,000. As an example, we would like the ability to create a new separate account(s) which accommodates SEC 3(c)(1) type of clients who own investments of at least \$1,000,000 or who generally have income of \$200,000 to \$300,000 per year. This flexibility would provide the company the ability to utilize the contract for various types of clients.

Please note that no changes, other than those identified above, have been made to the approved Private Placement Variable Annuity contract.

The forms have not been scored for readability since they are subject to federal regulation and therefore exempt from the Life and Health Insurance Policy Language Simplification Act.

Unless otherwise informed, we reserve the right to alter the layout of the enclosed forms, including sequential ordering of the provisions, and type font, size and color.

Any change of Owner may have income tax consequences.

**Change of Annuitant.** An Owner who is not a natural person may change the Annuitant or name a new Annuitant if the Owner, Annuitant and Company agree in writing to allow such change at the time the contract is issued. However, an Owner who is not a natural person may not change the Annuitant or name a new Annuitant following the death of the Annuitant. In all other instances the Annuitant may be changed (subject to our underwriting rules in effect at that time) at any time before income payments begin under an Income Plan.

Any change of Annuitant may have income tax consequences.

## SEPARATE ACCOUNT PROVISIONS

**Separate Account.** The Separate Account(s) named on the Schedule Page is a segregated investment account established by the Company under Delaware law to separate the assets funding the variable benefits for the class of policies to which this contract belongs from the other assets of the Company. That portion of the assets of the Separate Account equal to the reserves and other contract liabilities with respect to the Separate Account shall not be chargeable with liabilities arising out of any other business We may conduct. Income, gains and losses, whether or not realized from assets allocable to the Separate Account, are credited to or charged against such account without regard to Our other income, gains or losses.

**Investments of the Separate Account.** The Separate Account is segmented into Divisions. Each Division invests exclusively in a separate portfolio of investments or a single investment fund. Net Premiums will be applied to the Separate Account and allocated to one or more Divisions as selected by the Owner. The minimum initial and additional amounts that may be allocated to each Division are shown on the Schedule Page. If the amount to be allocated to a Division is an allocation of premium, the amounts shown for each Division are the minimum premium amounts that may be allocated (after deducting any Applicable Taxes, Premium Expense Charge, or allocations to the other Divisions). From time to time We may add additional Divisions. Transfers may be made to and from the additional Divisions subject to the rules stated in the Transfer Provision and any new rules or limitations tied to such additional Divisions. We may also discontinue offering one or more Divisions as provided in the "Rights Reserved by Us" provision.

If interests in any investment fund underlying a Division becomes unavailable for investment by a Separate Account, or if the Company's Board of Directors deems further investment in the investment fund inappropriate, the Company may restrict further allocations to these Divisions or may substitute shares of another investment for shares already purchased under this contract as provided in "Rights Reserved by Us".

**"A" and "B" Classes of the Separate Account Divisions.** The Separate Account Divisions are divided into two classes: "Class A" and "Class B".

Due to the advance notice requirements and limitations on withdrawals from the Class B Divisions, the Company reserves the right to: (1) allocate a portion of each Net Premium to a Class A Division; and (2) redeem Account Value from a Class B Division and transfer the proceeds to a Class A Division from
