We are sending this notice pursuant to Section 689C.310(5)(a) of the Nevada Revised Statutes. This Nevada law requires that we notify the commissioner of insurance and chief regulatory officer of insurance in every state in which we are licensed to do business that we are planning to discontinue small employer group major medical health insurance forms in the State of Nevada. This discontinuance is unlikely to impact any current residents of your state; however, we will work with your administration regarding any affected residents.

The following forms are being discontinued and replaced in the State of Nevada: John Alden Life Insurance Company forms J-3000-CC-NV, J-3050-CC (NV) 4/2000 and J-4000-RR (NV).
