We submit the above referenced addendums for information only. The purpose of this submission is to correct an error in the original submitted actuarial memorandum used for policy forms UL1010AR and UL1020AR, which were approved by your Department on 10/20/2010, under SERFF Tracking No. ALSB-126794785, State Tracking No. 46988. Please note that these policies are currently not available for sale and neither policy has been issued in your state. They have a scheduled launch in February 2011.

The original actuarial memorandums submitted with the filing stated the premium expense charge of 6% would apply for premium payment in policy years 2 and on before it is added to the policy value. We intended the description to read that the premium expense charge would apply for all policy years. A premium expense charge of 6% applying in all years is consistent with how the sample policy data pages were put together as well as the actuarial exhibits included in the original actuarial memo.
