Dear Commissioner Bradford,

We are writing to inform you of several changes we are making to our existing insurance offerings in your state pursuant to Arkansas statutes section 23-79-153. These changes are being made in response to the Patient Protection and Affordable Health Care Act.

Effective June 15, 2010, we will no longer offer Time Insurance Company Form 496 for sale in the state of Arkansas. Effective September 15, 2010, we will no longer offer Time Insurance Company Form E499 for sale in the state of Arkansas. Effective September 23, 2010, we will no longer offer Time Insurance Company Form 244 for sale in the state of Arkansas. Current insureds are unaffected by these changes.
