Dear Commissioner Bradford:

We are writing to inform you that Mid-West National Life Insurance Company of Tennessee ("Mid-West") has made the decision to close its block of individual market health benefit plans. This filing is being submitted pursuant to the requirements of §23-79-153 of the Arkansas Insurance Code.

Mid-West intends to discontinue new sales of all individual market health benefit plans as of August 15, 2010. We will continue to administer the existing business in compliance with Arkansas and federal law. Mid-West will pool the experience of the closed block of business in compliance with the requirements of §23-79-153(b).
