Dear Commissioner Jay Bradford,

We are planning to discontinue several small employer group major medical health insurance forms in the State of Nebraska starting with renewal dates of March 1, 2011. Nebraska law requires that we notify each commissioner of insurance in every state in which we are licensed to do business. Therefore, we are sending this notice pursuant to Section 44-52-59(1)(e) of the Nebraska Revised Statutes. This discontinuance is unlikely to impact any current residents of your state; however, we will work with your administration regarding any affected residents.

The following forms are being discontinued and replaced in the State of Nebraska: Time Insurance Company form C99.100.SIG.ZZ and Union Security Insurance Company form C61.100.SIG.ZZ.
