On February 12, 2010, we received approval for a rate increase on SERFF Tracking # UNUM-126967856 for policy form CANMOD-AR and CANB-AR, et al in your state. Because of the poor economic environment, we did not implement this rate increase immediately.

We have now decided, in light of the continuing slow recovery, to defer this rate increase until further notice. We do not intend to implement this rate increase in any state at the present time.

While this policy is underperforming at current rates, the impact of deferring this rate increase is not material to the Company's overall performance. We hope that our action will help our customers keep their policies during these difficult times.
