Dear Sir or Madam:

We have enclosed, for your approval, 2 Group Annuity Contract Amendments. Forms G.GenAmend11-01 and G.GenAmend11-02 will be issued on a general basis by the General American Life Insurance Company ("General American") in connection with two closed blocks of group fixed annuity business. These forms are intended to revise group annuity contracts pursuant to our rights under the contracts. These forms do not replace any forms previously filed with the Department. General American is a life insurance company that is an affiliate of MetLife .

Form G.GenAmend11-01 will be used, primarily to revise the Contract Continuation provision in our Separate Account and Fixed Contracts. The amendment allows the Contractholder to cancel the contract and receive the Accumulated Value at anytime. The amendment also specifies that General American cannot cancel the contract without providing the Contractholder without at least 60 days prior written notice.

Form G.GenAmend11-02 will be used primarily to revise the Date of Discontinuance provision in our Pooled Separate Account Contracts. The amendment specifies that General American cannot cancel the contract without providing the Contractholder with out at least 60 days prior written notice.

The rights afforded to the Contractholder via these amendments are consistent with MetLife's general practices in issuing these types of contracts.

Please advise us whether Forms G.GenAmend11-01 and G.GenAmend11-02 are in accordance with the requirements of your Department. If there are additional questions in this regard, please contact me at the above.




