RE: Request for Discretionary Group Approval - Government Employees Benefit Association

Dear Commissioner Bradford:

The purpose of this letter is to request approval of a discretionary group, as provided for under 23-83-107 and 23-86-106(5) of the Arkansas Insurance Code.

The Group to which the contract will be issued is the Government Employees Benefit Association (GEBA) which is a nationwide association of government employees. This group contract will cover GEBA members for Group Term Life and Accidental Death and Dismemberment insurance. The contract for GEBA will be situated in Maryland, and is recognized by the State of Maryland as a "public employees association" group, as provided under Maryland Code § 17-205. Public employers or public employees associations.

For your information, we are attaching Actuarial Memoranda for the Group Term Life and Accidental Death and Dismemberment coverages. Coverage will be issued on the 83500 policy series of forms. This policy series was originally approved in Maryland on August 26, 1985 and in Arkansas on October 3, 1984.

Since we believe that issuance of a group contract to this client meets the requirements for consideration set forth in Sections 23-83-107 and 23-86-106(5), we ask that GEBA be approved as an eligible group for the issuance of life and accident coverage.
