As you may be aware, American Network Insurance Company (ANIC) ceased writing new business on October 3, 2008, and was placed into rehabilitation on January 6, 2009 by Order of the Commonwealth Court of Pennsylvania. On October 2, 2009, the Pennsylvania Insurance Department filed a petition that seeks an order of liquidation for ANIC. The final decision on liquidation is pending with the Commonwealth Court. A hearing on this matter commenced on January 31, 2011 and is ongoing. The Rehabilitation Order and the Liquidation Petition can be found on our website at www.pennntreaty.com.
