The purpose is to make modifications necessary to accommodate the elimination of valuation dates and transactions occurring on dates that fall on other than a business day, when such dates fall on the last day of a calendar month.

Currently, these contracts all define the last calendar day of a month as being a valuation day for the variable annuity accounts.

The endorsement:

- 1) redefines the term Valuation Day so that it no longer includes valuation dates occurring on the last day of the month when it is not a business day; and
- 2) eliminates any provisions that may have provided for making transactions effective on such non-business dates.

We want to assure the Department that these changes do not negatively affect or reduce the rights of contract holders and are necessary because:

- 1) there are no reference markets or securities to determine fair value, as required by the SEC, on non-business days. As such this change is viewed as a regulatory necessity;
- 2) it will align our processes with universal industry practice which does not calculate unit values on such non-business days; and
- 3) it will simplify and standardize TIAA's overall administrative procedures.

We have bracketed those elements that are being submitted as variable.

Please note that a certification of readability is not included as the products that the endorsement will be attached to are securities subject to federal jurisdiction.

The form will be pre-printed or laser emitted with identical language approved by the Department. We reserve the right to change the book-turn duplex printing, pagination, location of print lines and words, signature graphic, and the type of font (but not to a point size less than 10) of the form without resubmitting for approval.



Notwithstanding any other provision in your contract, no transaction available to you may be made effective on a day that is not a business day, except as follows: when a business day is the last day of a calendar month, annuity death benefit payment methods may begin on the next day even when it is a non-business day.
