As you may be aware, Penn Treaty Network America Insurance Company (PTNA) ceased writing new business on October 3, 2008, and was placed into rehabilitation on January 6, 2009 by Order of the Commonwealth Court of Pennsylvania. On October 2, 2009, the Pennsylvania Insurance Department filed a petition that seeks an order of liquidation for PTNA. The final decision on liquidation is pending with the Commonwealth Court. A hearing on this matter commenced on January 31, 2011 and is ongoing. The Rehabilitation Order and the Liquidation Petition can be found on our website at www.penntreaty.com.

In addition to ceasing all new business sales almost three years ago, PTNA terminated all of its agent appointments after it entered rehabilitation. As a result, there is no sales or agent data to report. It is our understanding that the intent of the report is to provide information that may identify inappropriate sales activities, and in light of the above, PTNA respectfully requests that this letter will serve to satisfy the department's requirement.
