This is an association that meets the requirements under Arkansas Insurance Code §23-97-305. Residents of Arkansas who are members of AARP may be eligible to apply for coverage under the policy. We previously filed documentation for AARP with the Department under SERFF Tracking Number GEFA-125251368, on September 19, 2007.

Genworth Life Insurance Company received full approval for policy form series 7053 by the District of Columbia on July 13, 2011 under its Long Term Care Insurance Act and Regulations. The District of Columbia has adopted the NAIC 2000 Long Term Care Insurance Model Regulations (Model 641SD), which includes rate stabilization requirements, as shown in the District of Columbia Municipal Regulations, under Title 26, Chapter 26.
