

Our current policy forms filed with your Department (policies, riders, endorsements & applications) specify the positions of National President and National Secretary-Treasurer as the authorized officers. Under recent amendments to the Laws of Woman's Life, which have been filed with your Department per A.C.A. 23-74-302(d) and which become effective May 1, 2012, the position of National Secretary-Treasurer will be divided into two separate positions (National Secretary and National Treasurer). As a result we will need to change the reference in our forms from National Secretary-Treasurer to National Secretary. There will be no other changes to the forms.
