Nationwide, is respectfully, notifying the Department of Insurance of the following:

The filing description for the above captioned submission incorrectly stated that Option VAR-0168AO.2 would be issued with Contracts VAC-0121AOCV.1 and VAC-0126AOCV.1.

Option VAR-0168AO.2 will only be utilized with Contract VAC-0121AOCV.1. Contract, VAC-0126AOCV.1 will utilize Option VAR-145AO.1, which was also approved as part of the same filing on 02/06/2012 (DOI # 50505).

Both of the referenced Options are Enhanced Death Benefits that offer the same features (greater of 1-year or 5% interest). The only substantive difference is the cost as the Options are priced taking into consideration the pricing of the product with which they will be used.

All of the actuarial materials provided with the original filing were accurate. The filing description was the only portion of the original submission that was inaccurate.

None of the above mentioned forms have been issued to any contract owner as the launch date for all of our new products is June 11, 2012.
