DENTAL GROUP BENEFIT CERTIFICATES**

AMENDMENT NO. 2652

ELIGIBILITY AND EFFECTIVE DATE OF COVERAGE, Provision A.2. is hereby amended to add the following provisions:

- c. **Effective Date for Temporary Employees going to Hourly Full-Time Status.** Subject to all other terms, conditions, exclusions and limitation in the Plan as set forth in this Benefit Certificate, a temporary employee who has worked a minimum of thirty-two (32) hours per week for at least three (3) consecutive months of continuous employment and subsequently transfer to full-time status will be exempt from satisfying Waiting Period. Coverage will become effective on the first day of the Policy Month following the date of hire as a full-time employee.

This Amendment becomes a part of the Arkansas Blue Cross and Blue Shield DentalBlue Group Benefit Certificates. All other provisions of the Group Benefit Certificate remain in full force and effect.
