The Employer hereby agrees to indemnify Coventry for any costs or penalties it may incur due to the Employer’s failure to timely provide the SBC document to the Group’s plan participants and beneficiaries.

Except as stated herein nothing other than the specified provisions in this document shall be deemed altered.
