To Whom It May Concern:

This letter is regarding the Medicare Select Network Provider Report for the 4th quarter of 2012.

With our original filing, we included a list of network hospitals that had signed agreements to participate in the select program. Prior to July 28, 2012, Medico utilized two networks, MedCare Advantage and USA MCO. On July 28, 2012, the contract between Medico and USA MCO was terminated. The remaining active network, MedCare Advantage, does not currently have any participating hospitals in Arkansas. As such, there is not a list of participating hospitals to provide.

In those situations in which an insured does not have a participating hospital within 50 miles of their residence, Medico will pay for the Part A deductible.
