Generally, medical applications are required for each employee of a group seeking health insurance coverage for groups with between 26 and 50 employees. Similar to the approach taken by other carriers in the market, QualChoice will waive the requirement that each employee in a group this size complete a medical application if: (1) historical claims experience is provided for the group, (2) this "Health Addendum to Employer Application" is submitted, and (3) the responses to the "Health Addendum" do not trigger additional questions that would warrant medical applications from each employee.
