NOTICE OF HEARING

Dear Mr. Felts:

You are hereby notified that an administrative hearing has been scheduled pursuant to Ark. Code Ann. §§ 23-61-303 and other applicable provisions of Arkansas law, before Insurance Commissioner Allen Kerr, as Hearing Officer, or his designee, on October 27, 2016 at 1:30 p.m. in the First Floor Hearing Room, Arkansas Insurance Department ("Department"), 1200 West Third Street, Little Rock, Arkansas. You have the right to represent yourself or be represented by legal counsel of your own choosing at this proceeding. Additionally, the Commissioner will obtain a competent reporter to record the hearing. You may avail yourself of other privileges, including the Department's assistance to subpoena any needed witnesses or records.

The allegations against you are:

- 1) Having an insurance producer license or its equivalent denied, suspended, or revoked in any other state, province, district, or territory, a violation of Ark. Code Ann § 23-64-512(a)(13). Specifically, you were denied a license in Wisconsin and Mississippi due to a criminal background check and felony conviction.
- 2) Failing to provide a written response after receipt of a written inquiry from the Commissioner or his or her representative as to transactions under the license within thirty days after receipt of thereof unless the timely written response is knowingly waived in writing by the Commissioner. Ark Code Ann. § 23-64-512(a)(13). Specifically, you have failed to respond to any written request from the Arkansas Insurance Department regarding your recent license denials from Wisconsin and Mississippi.

Each of these issues shall be presented at your hearing, but the Department is not limited to only these allegations may our investigations uncover further wrongdoing.

Your verbal or written notification that you have received this notice of hearing must be received in this office within ten (10) days of your receipt. If your notification is not received by the Department within ten (10) days, any and all expenses incurred by the Department in continuing the hearing or in notification of witnesses, including but not limited to, phone calls, issuance of subpoenas and postage, will be charged to the party or parties requesting such continuance. If you or your attorney determines that a continuance is necessary, or you have questions or concerns, please contact me at (501) 371-2829.
