REVOCATION ORDER

On this day, the matter of Moses Torres (“Respondent”) comes before Jay Bradford, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Ava Franks, Associate Counsel, in this matter.

FINDINGS OF FACT

1. Respondent holds Arkansas Nonresident Producer License No. 382852.
2. On or about June 20, 2013, in the Superior Court of Washington for Clark County, Respondent pled guilty to two counts of child molestation and attempted rape of a child, both felonies.
3. Respondent did not disclose the aforementioned matter to the Department within thirty (30) days.

CONCLUSIONS OF LAW

From the Findings of Fact contained herein, the Commissioner concludes as follows:

4. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Ark. Code Ann. §23-61-103.

5. Respondent failed to disclose his conviction to the Department within thirty (30) days as required by Arkansas Code §23-64-517(b)(1).

RECOMMENDATION OF THE HEARING OFFICER

WHEREFORE, based upon the foregoing Findings of Fact, Conclusions of Law, and other matters before him, the Hearing Officer recommends:

7. Respondent's Arkansas Nonresident Producer License No. 382852 should be revoked.




