REVOCATION ORDER

On this day, the matter of Marc Robbins (“Respondent”) came before Jay Bradford, Arkansas Insurance Commissioner (“Commissioner”). A hearing was held on May 7, 2014 at 9:00 a.m. in the Hearing Room of the Arkansas Insurance Department (“Department”) pursuant to a Notice of Hearing dated April 7, 2014. The hearing was held before Deputy Commissioner and General Counsel, William R. Lacy (“Hearing Officer”), pursuant to his appointment by the Commissioner in accordance with Arkansas Code Annotated § 23-61-103. The Department was represented by Amanda J. Andrews, Associate Counsel, and Respondent did not appear at the hearing.

FINDINGS OF FACT

1. Respondent is a resident of Virginia and holds Arkansas Non-Resident Producer License No. 405719, which was issued on August 13, 2012.
2. When Respondent applied for an Arkansas Non-Resident Producer License, he stated on the application that he had not been involved in an administrative proceeding involving a professional or occupational license.

3. Respondent submitted false information on the application for an Arkansas Non-Resident Producer License, in that he failed to disclose the following:

- a. On July 17, 2009, Respondent surrendered his producer license in Ohio.
- b. On September 8, 2009, Kentucky revoked Respondent's producer license.

4. After obtaining a producer license in Arkansas, a number of jurisdictions took administrative action against Respondent, and he failed to disclose the actions. The actions are as follows:

- a. On September 12, 2012, Kansas revoked Respondent's producer license.
- b. On September 20, 2012, Colorado denied Respondent's application for a producer license.
- c. On September 27, 2012, Connecticut denied Respondent's application for a producer license.
- d. On October 8, 2012, Wisconsin denied Respondent's application for a producer license.
- e. On November 6, 2012, Pennsylvania denied Respondent's application for a producer license.
- f. On November 9, 2012, Maine denied Respondent's application for a producer license.
- g. On December 14, 2012, Indiana denied Respondent's application for a producer license.
- h. On January 2, 2013, South Dakota denied Respondent's application for a producer license.

i. On April 22, 2013, Virginia, Respondent's home state, revoked Respondent's producer license.

j. On January 24, 2014, West Virginia revoked Respondent's producer license.

5. The Department properly served Respondent with the Notice of Hearing by sending the notice via regular United States Mail and Certified Mail to the addresses provided to the Department by Respondent. Respondent did not appear for the administrative hearing.

CONCLUSIONS OF LAW

From the Findings of Fact contained herein, the Commissioner concludes as follows:

6. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Arkansas Code Annotated § 23-61-103.

7. Arkansas law requires a licensee to report any administrative action taken against him in another jurisdiction or by another governmental agency in this state within thirty (30) days after the final disposition of the matter. Ark. Code Ann. § 23-64-517(a).

8. The Commissioner may revoke a producer's license for any one (1) or more of the following causes: providing incorrect, misleading, incomplete, or materially untrue information in the license application; violating a law of this or any state; using fraudulent, coercive, or dishonest practices or demonstrating incompetence, untrustworthiness, lack of good personal or business reputation, or financial irresponsibility; or having an insurance producer license or its equivalent denied, suspended, or revoked in any other state, province, district, or territory. Ark. Code Ann. § 23-64-512(a).

9. Respondent submitted false information on the application for an Arkansas Non-Resident Producer License, and failed to disclose to the Department administrative actions against him in other jurisdictions, in violation of Arkansas law.

RECOMMENDATIONS OF THE HEARING OFFICER

WHEREFORE, based upon the foregoing Findings of Fact, Conclusions of Law, and other matters before him, the Hearing Officer recommends:

Based upon the Respondent's submission of false information on the application for an Arkansas Non-Resident Producer License and failure to disclose to the Department administrative actions against him in other jurisdictions, maintain a producer license in good standing in his home state, and appear before the Department for the administrative hearing, all in violation of Arkansas law, I recommend that the Respondent's Arkansas Non-Resident Insurance Producer License, number 405719, be revoked.
