REVOCATION ORDER

On this day, the matter of William Moates, Jr., (“Respondent”) comes before Allen Kerr, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Gray Allen Turner, Associate Counsel, in this matter.

FINDINGS OF FACT

1. Respondent holds Arkansas Resident License, National Producer Number 1910807.
2. On or about February 17, 2015, Respondent was requested to attend an Investigative Conference scheduled for March 4, 2015. Mr. Moates was requested to bring copies of two specific client files, including applications, statements, disbursements, and payment on the client accounts.
3. Mr. Moates did not appear at the investigative conference and has not provided the copies as requested.

4. Mr. Moates did not appear at the March 26, 2015, administrative hearing despite being provided adequate notice.

CONCLUSIONS OF LAW

From the Findings of Fact contained herein, the Commissioner concludes as follows:

5. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Ark. Code Ann. § 23-61-103.

6. Respondent failed to provide a written response after receipt of a written inquiry and has failed to cooperate in an investigation as per Ark. Code Ann. § 23-64-512(a)(13).

RECOMMENDATION OF THE HEARING OFFICER

WHEREFORE, based upon the foregoing Findings of Fact, Conclusions of Law, and other matters before her, the Hearing Officer recommends:

7. Respondent's Arkansas Resident Producer License, NPR No. 1910807 should be revoked.
