EMERGENCY SUSPENSION ORDER

On this day, the matter of Mark Kimbrough (“Respondent”) came before Allen Kerr, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Gray Allen Turner, Associate Counsel, in this matter. From the facts and law before him, the Commissioner finds as follows:

FINDINGS OF FACT

1. Respondent holds an Arkansas Resident Producer License, National Producer Number 17704662. Respondent resides in Sherwood.

2. On July 18, 1997, Respondent was convicted of Bank Fraud, a violation of 18 U.S.C. § 1344 and a Class B Felony, in the Eastern District of Arkansas, case Number 4:96CR00279-001.

3. Respondent did not submit a copy of his felony conviction as part of his September 3, 2015, Arkansas producer license application.

4. Respondent does not have a U.S.C. §1033 waiver and does not have permission to work in the business of insurance.

5. Respondent has applied for non-resident producer license in several states.

6. The public health, safety, and welfare imperatively require emergency action.

CONCLUSIONS OF LAW

From the Findings of Fact contained herein, the Commissioner concludes as follows:

1. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Ark. Code Ann. § 23-61-103.

2. The Commissioner has the authority to issue an emergency license suspension pursuant to Ark. Code Ann. §§ 23-64-216(e) and 25-15-211(c).


3. An administrative hearing will be held promptly, as required by Ark. Code Ann. § 23-64-216(e)(2). A Notice of Hearing is being served herewith.

5. The Commissioner and the Department reserve the right to amend the allegations, findings and conclusions set forth herein and further reserve the right to present additional allegations and evidence in any subsequent order or administrative hearing.

IT IS THEREFORE ORDERED:

In consideration of the Commissioner's Findings of Fact and Conclusions of Law, the Respondent's Arkansas Non-Resident Producer License, National Producer Number 17704662, is hereby immediately suspended.
