REVOCATION ORDER

On this day, the matter of the producer's license of Corey Franks ("Respondent") came before Allen Kerr, Arkansas Insurance Commissioner ("Commissioner"). A hearing was held on January 14, 2016, in the First Floor Hearing Room of the Arkansas Insurance Department ("Department") pursuant to the Notice of Hearing dated December 17, 2015. The hearing was held before Chief Deputy Commissioner Russ Galbraith ("Hearing Officer") pursuant to his appointment by the Commissioner in accordance with Ark. Code Ann. § 23-61-103(e)(1). The Department was represented by Gray Allen Turner, Associate Counsel. The Respondent was not present.

FINDINGS OF FACT

1. The Commissioner of Insurance has jurisdiction pursuant to the Arkansas Insurance Code, specifically Ark. Code Ann. §§ 23-60-101, *et seq.*
2. Respondent was sent a notice of hearing on December 17, 2015, by certified and first-class mail. (Exhibit 2). Mr. Franks did not respond to the notice of hearing.

3. Respondent resides in Arkansas.
4. Mr. Franks was three or more months in arrears on his child support obligations according to a letter sent by the Arkansas Office of Child Support Enforcement on December 4, 2015. (Exhibit 4).

CONCLUSIONS OF LAW

1. Ark. Code Ann. § 9-14-239 requires the suspension of licenses held by noncustodial parents who are three months or more in arrears on their child support. Mr. Franks' failure to fulfill his child support obligations also demonstrates financial irresponsibility is therefore a violation of Ark Code Ann. § 23-64-512(a)(8).

RECOMMENDATION OF HEARING OFFICER

WHEREFORE, upon consideration of the evidence of record and the foregoing Findings of Fact and Conclusions of Law, the Hearing officer recommends the following:

1. That the Arkansas Insurance Producer's license of Respondent Corey Franks be revoked
