**Everest National Insurance Company  
Actuarial Memorandum**

Everest National Insurance Company (ENIC) has recently formed a strategic alliance with the Mattei Insurance Company, a Program Administrator. Mattei has historically performed as a Program Administrator, writing business primarily through the Stonington Insurance Company.

We are filing rates identical with those currently charged by Stonington. ENIC does not have any of its own experience or data upon which to develop rates for these two endorsements.

- ECG 20 540 07 07 – Additional Insured – Designated Person Or Organization – Primary Coverage

ENIC is proposing a charge of \$250 which is consistent with our existing charge for similar endorsements (e.g. Additional Insured - Automatic Status When Required in a Written Agreement With You ECG 20 506) written by other programs.

In addition, the charge is consistent with Stonington's existing charge for Additional Insured endorsements.
