- D. SECTION IV - BUSINESS AUTO CONDITIONS**, Item B.5. Other Insurance, Items a. and b. are deleted and replaced by:
  - a.** For any covered "auto" you own which is a trailer, the insurance provided by this Coverage Form is excess over any other collectible insurance.
- E. SECTION V - DEFINITIONS** is changed to add the following definitions:
  - Q.** "One Way or Local Rental System" means any person, organization, or other entity in the business of hiring, renting or leasing a motor vehicle or trailer.
