This is to record the fact that we will use the ISO Filing Designation Number shown above, which will become available for use in Arkansas on policies written on or after December 1, 2008. We are NOT required to file anything with the Arkansas Department of Insurance since we previously filed to have our loss cost multipliers apply to subsequent revisions of ISO loss costs, and because we are adopting rate revision without change, on the ISO effective date.
