Comment: We can approve the change in the threshold from \$1,000,000 to \$250,000. We will take this opportunity to remind you that NCCI's filing indicates that the premium for a Large Risk Alternative Rating Option (LRARO) policy is "mutually agreed upon" and no further filing is needed. Arkansas law requires that ALL workers' compensation rates must be approved before use. Large Risks are not exempt. Unless your company has filed the rates that will be used with the LRARO program, then an individual risk filing will need to be made for each insured.
