THIS ENDORSEMENT CHANGES THE POLICY. PLEASE READ IT CAREFULLY.

Extended Property Damage Amendment

This endorsement modifies insurance provided under the following:

COMMERCIAL GENERAL LIABILITY COVERAGE PART

Schedule

With respect to your business operations and ownership, the following provisions apply:

A. Coverage Extensions

The following coverage extensions apply subject to Provision **C. Limits of Insurance** of this endorsement:

1. Property Damage Liability Extension

- a.** The following is added to Paragraph **2. Exclusions of Section I - Coverage A Bodily Injury And Property Damage Liability**:

Provisions **(5)** and **(6)** of Exclusion **j. Damage To Property**, do not apply to "property damage":

(1) To that particular part of any property, not on premises owned by or rented to the insured:

(a) Upon which the insured is performing operations, if the "property damage" arises out of those operations; or

(b) That must be restored, repaired or replaced because "your work" was incorrectly performed on it.

- b.** The following is added to Paragraph **2. Exclusions of Section I - Coverage A Bodily Injury And Property Damage Liability**:

Exclusion **I. Damage To Your Work**, does not apply to "property damage":

(1) To that particular part of any property, not on premises owned by or rented to the insured:

(a) Upon which the insured performed operations, if the "property damage" arises out of those operations; or

(b) That must be restored, repaired or replaced because "your work" was incorrectly performed on it.

B. Deductibles

- a. Our obligation under this endorsement to pay damages on your behalf applies only to the amount of damages in excess of any deductible amounts shown in the Schedule.

The deductible applies to the applicable coverage afforded by this endorsement because of "property damage" resulting from any one claim.

- b. The terms of this insurance, including those with respect to:

- (1) Our right and duty to defend any "suits" seeking those damages; and

- (2) Your duties in the event of an "occurrence", claim or "suit";

apply irrespective of the application of the deductible amount.

- c. We may pay any part or all of the deductible amount to effect settlement of any claim or "suit" and, upon notification of the action taken, you shall promptly reimburse us for such part of the deductible amount as has been paid by us.

C. Limits of Insurance

The following is added to Section **III** – Limits Of Insurance:

- 8. Subject to Paragraph **2.** or Paragraph **3.** above, whichever applies, the Property Damage Liability Extension Aggregate Limit shown in the Schedule of this endorsement is the most we will pay for the sum of all damages under Property Damage Liability Extension.

All other terms, conditions and exclusions shall remain the same.
