2. Jewelry stock must be kept in locked show cases while at the show or exhibition except while being shown to customers.
3. Jewelry stock must be kept in a guarded security room or locked safe after show or exhibition hours.
4. Jewelry stock may not be left in or on a vehicle that is not attended while in transit to or from the show or exhibition. This provision does not apply while the property being shipped is in the custody of the U.S. Postal Service as Registered Mail or Express Mail, an armored car service, a private parcel delivery service or a common carrier.

Explanatory Memorandum

The IM-F-152 Jewelry Show Or Exhibition Coverage Endorsement was developed to provide coverage for jewelers who attend shows and exhibitions. It covers jewelry stock while at the show/exhibition as well as in transit to and from. This is a fill-in endorsement which requires the name of the show, location, dates, limit of insurance and deductible. Separate limits are provided for the show/exhibition and the transit coverages.

Approval for use of the form must be obtained from the H.O. Underwriting Department. A minimum of 30 days advance notice should be provided in order to process. This includes developing the premium and arranging for reinsurance if necessary.
