COMMERCIAL UMBRELLA LIABILITY

32. TERRORISM ENDORSEMENT OPTIONS - FEDERAL BACKSTOP

A.1. is replaced with the following:

- A.** When coverage for certified acts of terrorism is to be provided, the following options are available:
- 1.** To provide coverage for both certified acts of terrorism and other acts of terrorism (subject to underlying policy provisions), but provide that the insurer will not pay any amount for injury or damage for any certified act of terrorism after the amounts of all such events in a statutory period exceed the cap provided by the Act, use Cap On Losses From Certified Acts Of Terrorism Endorsement **71 1071**.
