- (5) Computer programs (computer software), including but not limited to, applications, and related software;
- (6) Computer parts, including but not limited to, microprocessors, microchips, and related components.

(6) Any other computerized or electronic information or component...

...of the items in Paragraph 1.a. of this endorsement;

due to the inability to correctly recognize, identify, distinguish, interpret or accept...
