EXPLANATORY

Deductible Rule, Property and Commercial Multi-Peril - **Withdrawal**

Rule 81 Deductible Plan – Property

Rule 1.B. III COMPAC – Deductible Plan

On behalf of the stated insurance companies, we are filing to withdraw our approved Commercial Property Deductible Plan, and our CMP [COMPAC] Deductible Plan; each of which is exactly the same Plan, for each of the two referenced lines of business.

We are standardizing our small deductible program country wide, to match ISO's Rule 81. That Rule provides more deductible options than the company specific rule that was approved almost a decade ago. Therefore policyholders will still have the option of selecting a small deductible.
