CLOSING PROTECTION COVERAGE

The coverage provided by a Closing Protection Letter is limited to a specific residential real estate transaction. The fee for the issuance of a Closing Protection Letter indemnifying a seller, lessee, or purchaser of an interest in land, a borrower, or a lender secured by a mortgage, including any other security instrument, of an interest in land shall be \$25 for the first covered party and \$15 for each additional covered party. The entire rate for the Closing Protection Letter shall be retained by the Insurer.
