**EXPLANATORY MEMORANDUM
INLAND MARINE
RURAL TELECOMMUNICATIONS (TELCOM INSURANCE GROUP)
PROGRAM FORMS**

The purpose of this filing is to file a new inland marine form to be used with Telcom Insurance Group program that is designed to cover the specific exposures of small and rural telephone cooperatives and commercial companies.

**CM 82 72 (Ed. 09/07) – Select Business Policy Rural Telecommunications Companies
Accounts Receivable Extension Endorsement**

The **CM 8272** amends the Accounts Receivable Coverage Form to:

- extend coverage to include credit and charge card slips
- amend exclusion for programming errors or faulty machine instructions to highlight that this exclusion does not include loss or damage by computer virus or other malicious software
- removal of the coinsurance clause from application.
