EXPLANATORY MEMORANDUM

Background

On December 26, 2007, The President of the United States signed the Terrorism Risk Insurance Program Reauthorization Act of 2007 extending TRIA, with certain modifications, for seven additional years. In part, the Act revises the definition of an act of terrorism (with respect to certification of such act) by eliminating the criterion that the act be committed on behalf of a foreign person or foreign interest. Zurich has commenced with the necessary filings addressing the recent modifications of the Act.

Withdrawn Forms

The purpose of this filing is to update our proprietary terrorism portfolio of forms by withdrawing prior approved forms and rules that are no longer required or compliant with the modifications imposed by the Terrorism Risk Insurance Program Reauthorization Act of 2007. We are taking this opportunity to withdraw outdated terrorism related forms that were approved post 9-11 and prior to the creation of Terrorism Risk Insurance Act, ("TRIA"). Thus, the revised portfolio of our proprietary terrorism forms will pertain solely to "certified acts of terrorism" as set forth in the aforementioned filings.
