### Claims

All Proof of Loss notices must be submitted to the Arkansas Governmental Bonding Board by the Division of Legislative Audit.

Coverage is provided only for funds audited in compliance with Section 4 of the Bond policy. Private audits must be completed within (18) months of the close of each participating governmental entity's fiscal year.
