The Company's health insurer fee impact is \$36,706 in 2014, which was paid in September 2014.

The agreement has been approved by the Department and will replace the previous agreement with Express Scripts, formally Medco Health Solutions, Inc.

Effective January 1, 2014, the Company entered into a behavioral health management agreement with an affiliated entity, United Behavioral Health, a subsidiary of OptumHealth Holdings, LLC. to provide behavioral health benefit management services for the Medicare product. The agreement has been approved by the Department.

Effective May 1, 2014, the Company has an agreement with OptumInsight, Inc., an affiliate of the Company, for services that lead up to and include the prevention and recovery of medical expense (benefit) overpayments. The agreement has been approved by the Department.

Level 3 — Unobservable inputs that cannot be corroborated by observable market data.

The estimated fair values of bonds and short-term investments are based on quoted market prices, where available. The Company obtains one price for each security primarily from a third-party pricing service (“pricing service”), which generally uses quoted prices or other observable inputs for the determination of fair value. The pricing service normally derives the security prices through recently reported trades for identical or similar securities, making adjustments through the reporting date based upon available observable market information. For securities not actively traded, the pricing service may use quoted market prices of comparable instruments or discounted cash flow analyses, incorporating inputs that are currently observable in the markets for similar securities. Inputs that are often used in the valuation methodologies include, but are not limited to, non-binding broker quotes, benchmark yields, credit spreads, default rates and prepayment speeds. As the Company is responsible for the determination of fair value, it performs quarterly analyses on the prices received from the pricing service to determine whether the prices are reasonable estimates of fair value. Specifically, the Company compares the prices received from the pricing service to a secondary pricing source; prices reported by its custodian, its investment consultant and third-party investment advisors. Additionally, the Company compares changes in the reported market values and returns to relevant market indices to test the reasonableness of the reported prices. The Company’s internal price verification procedures and review of fair value methodology documentation provided by independent pricing services have not historically resulted in an adjustment in the prices obtained from the pricing service.

In instances in which the inputs used to measure fair value fall into different levels of the fair value hierarchy, the fair value measurement has been determined based on the lowest-level input that is significant to the fair value measurement in its entirety. The Company’s assessment of the significance of a particular item to the fair value measurement in its entirety requires judgment, including the consideration of inputs specific to the asset or liability.

The liability for claims unpaid, accrued medical incentive pool and bonus amounts, aggregate health claim reserves, health care receivable and reinsurance recoverables as of December 31, 2013 were \$96,266. As of September 30, 2014, \$122,920 has been paid for incurred claims attributable to insured events of prior years. Reserves remaining for prior years, net of health care receivable are (\$42,240) as a result of re-estimation of unpaid claims. Therefore, there has been \$15,586 favorable prior year development since December 31, 2013 to September 30, 2014. The primary drivers consist of favorable development as a result of a change in the provision for adverse deviations in experience of \$9,471, favorable development of pharmacy rebates of \$16,397, and favorable development from provider settlements of \$2,937 offset by unfavorable development of \$1,878 in retroactivity for inpatient, outpatient, physician, and pharmacy claims, and unfavorable development for Part D activity of \$10,777. At December 31, 2013, the Company recorded \$59,257 of favorable development related to a change in the provision for adverse deviations in experience of \$7,750, favorable development of \$44,389 in retroactivity for inpatient, outpatient, physician and pharmacy claims, favorable development for pharmacy rebates of \$13,326 offset by unfavorable development for Part D retroactivity of \$6,470. Original estimates are increased or decreased, as additional information becomes known regarding individual claims. Included in this favorable development is the impact related to retrospectively rated policies. As a result of the prior year effects, on a regular basis, the Company adjusts revenue and the corresponding liability and/or receivable related to retrospectively rated policies and the impact of the change is included as a component of change in reserve for rate credits in the statutory basis statements of operations.

The above table reflects a prior year reserve of (\$9,095) comprised of \$1,796 of accrued medical incentive pool and bonus amounts offset by (\$10,891) of negative incurred but not reported ("IBNR") reserve as of September 30, 2014. The negative prior year IBNR is due to expected recoveries of claims overpayments offset by normal claims payable.

The Company incurred claims adjustment expenses of \$28,811 and \$36,730 for the nine months ended September 30, 2014 and the year ended December 31, 2013, respectively. 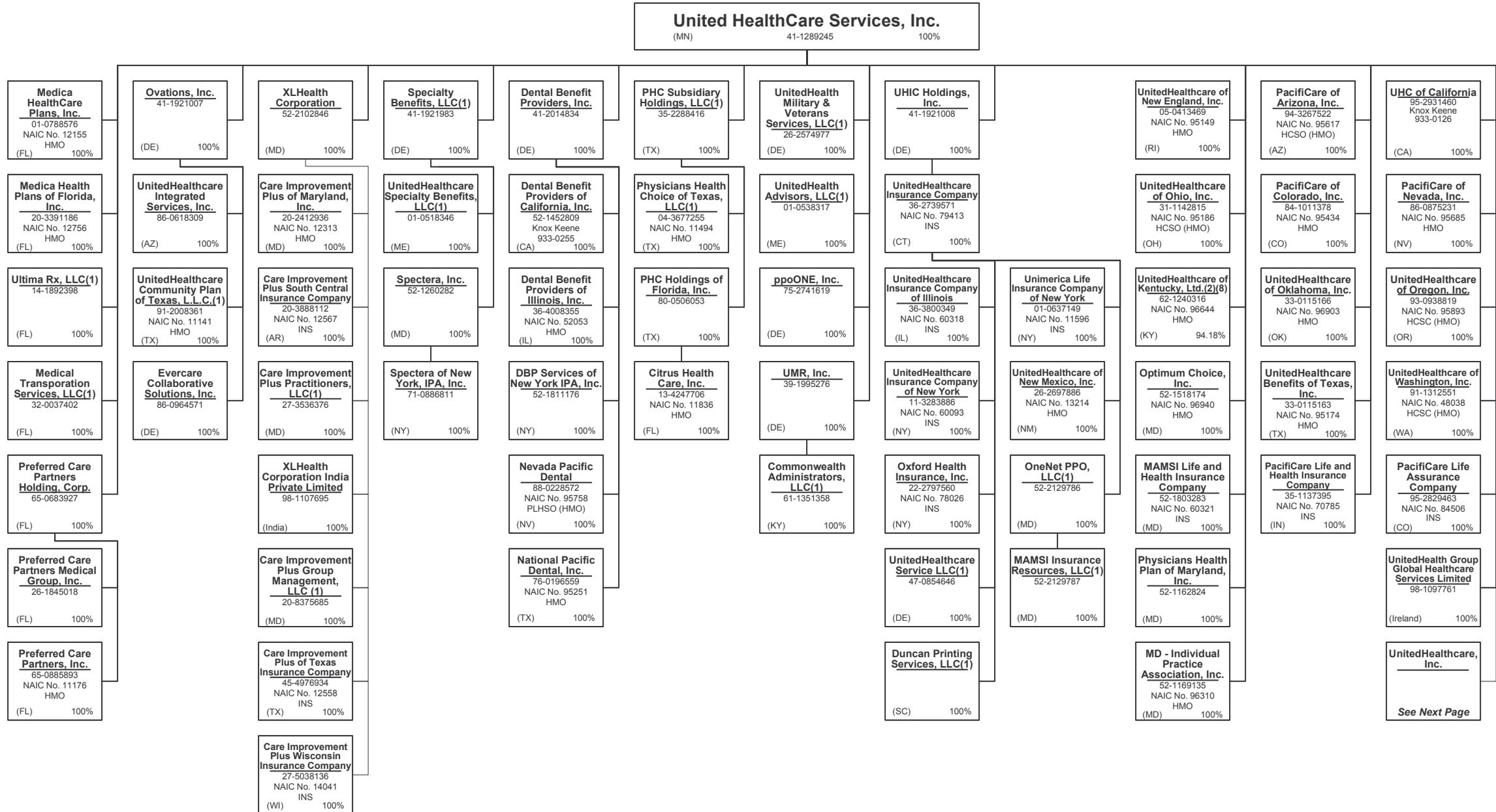

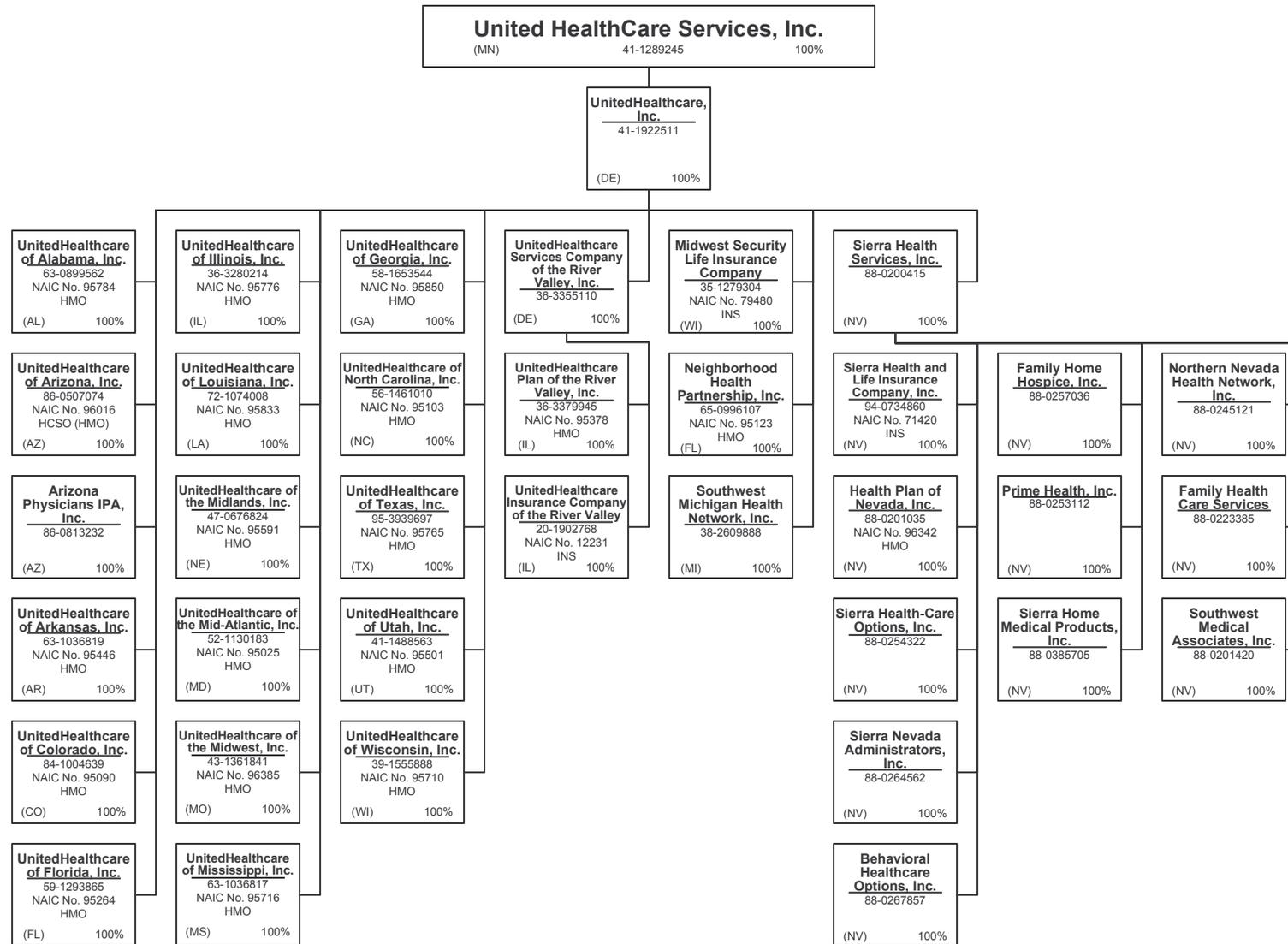

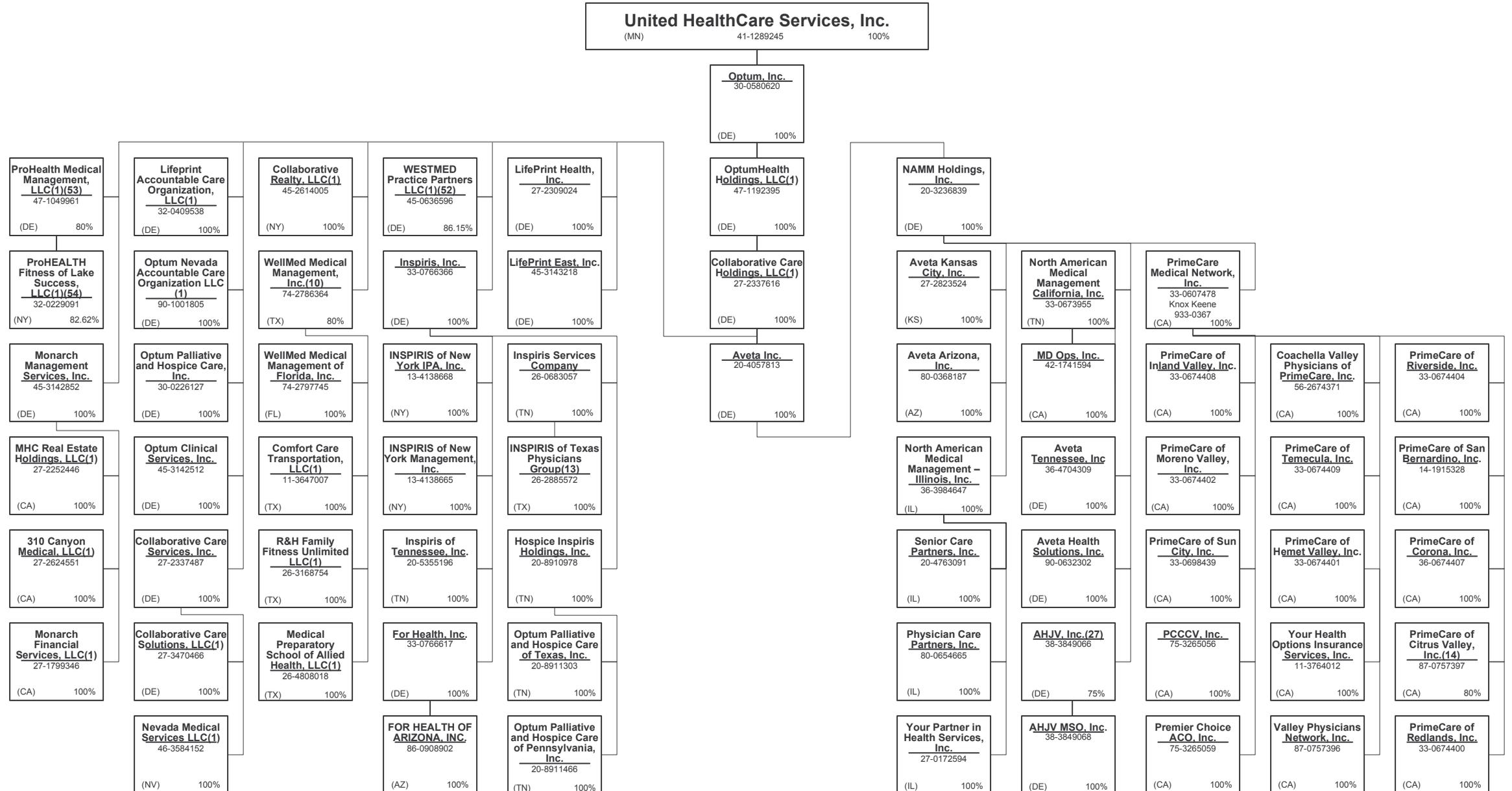

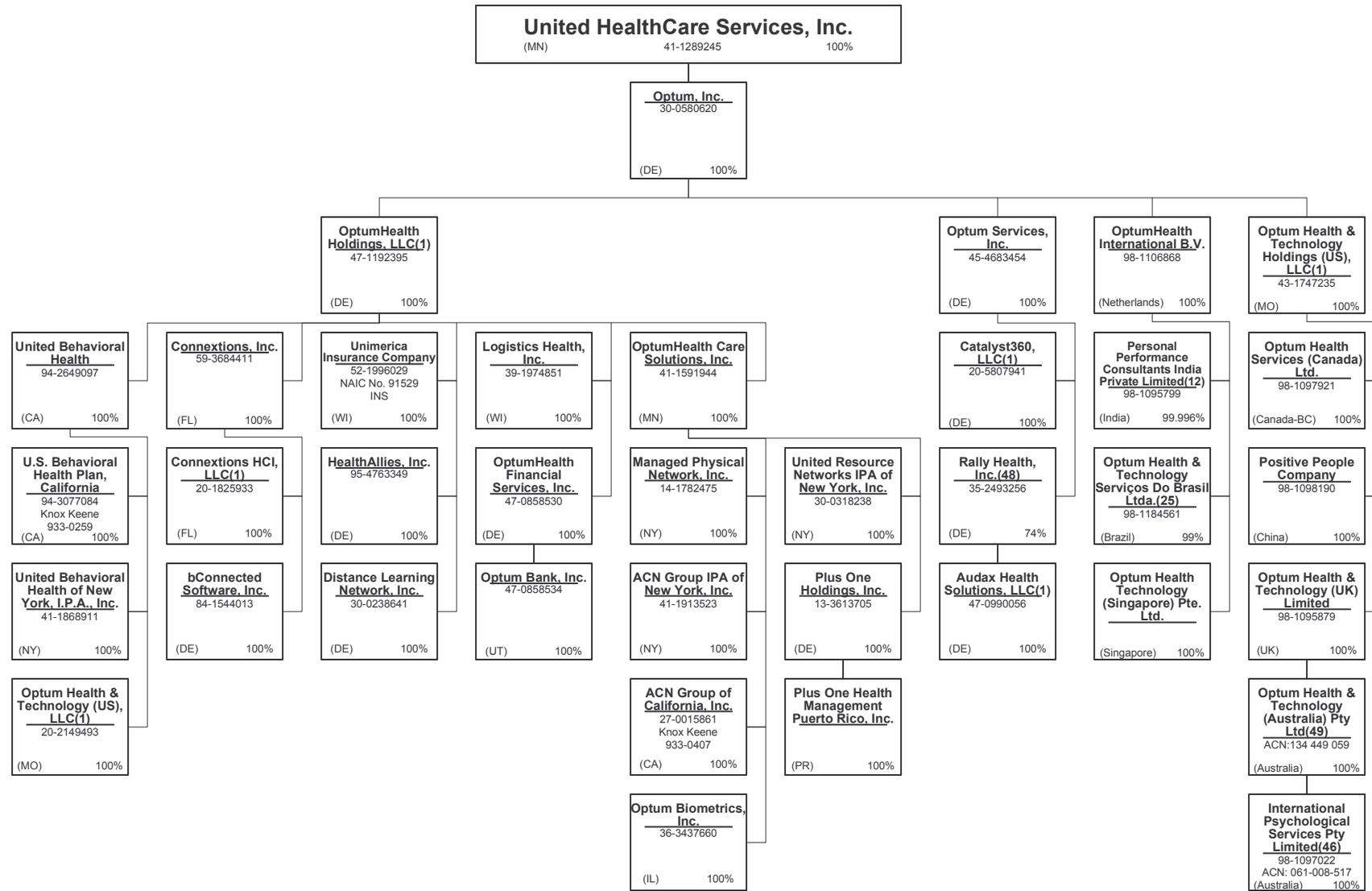

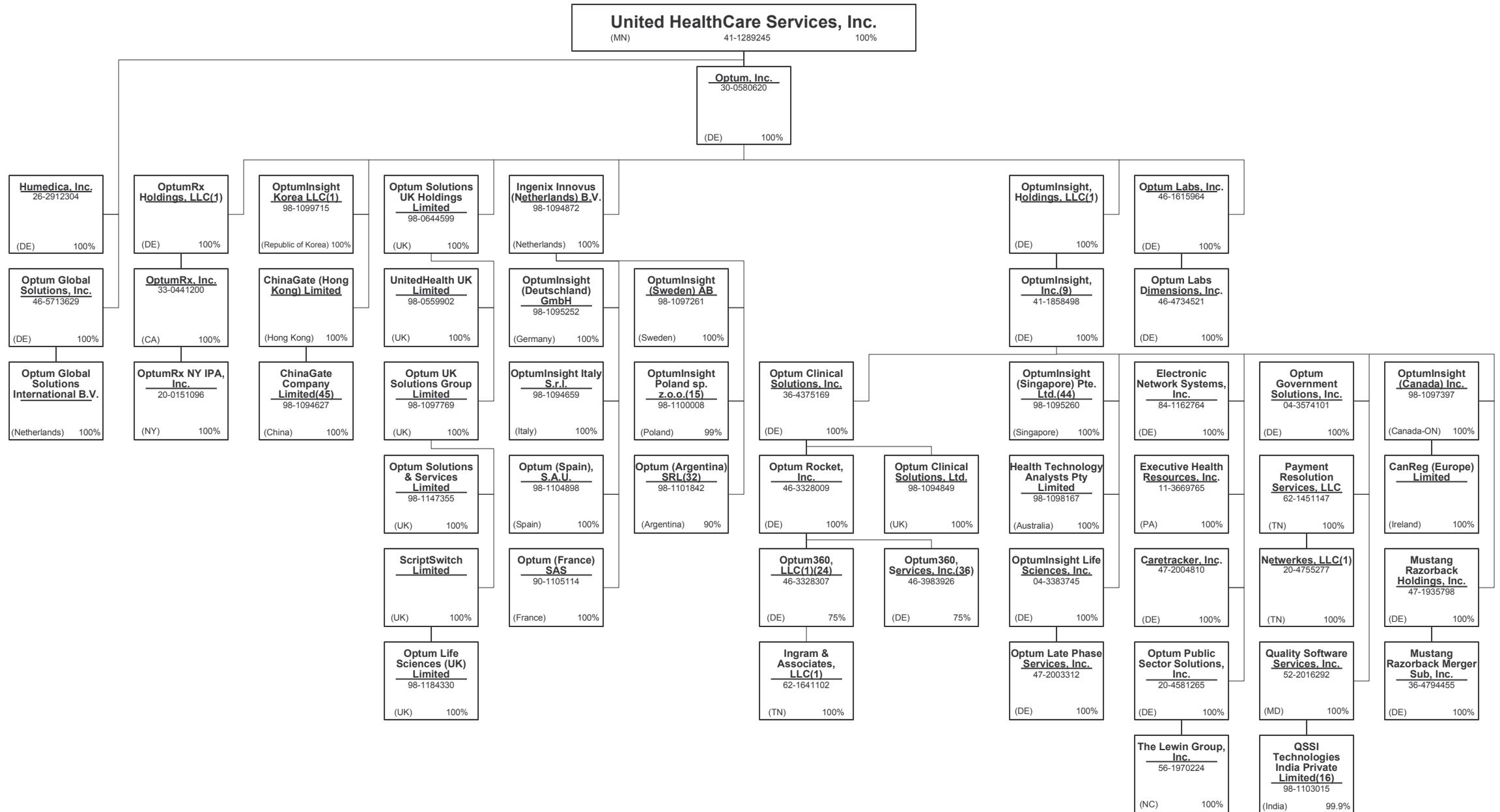
