REVOCATION ORDER

On this day, the matter of the producer's license of Shawn Chamizo ("Respondent") came before Allen Kerr, Arkansas Insurance Commissioner ("Commissioner"). A hearing was held on October 27, 2015, in the First Floor Hearing Room of the Arkansas Insurance Department ("Department") pursuant to the Notice of Hearing dated September 16, 2015. The hearing was held before Chief Deputy Commissioner Russ Galbraith ("Hearing Officer") pursuant to his appointment by the Commissioner in accordance with Ark. Code Ann. § 23-61-103(e)(1). The Department was represented by Gray Allen Turner, Associate Counsel. The Respondent was not present.

FINDINGS OF FACT

1. The Commissioner of Insurance has jurisdiction pursuant to the Arkansas Insurance Code, specifically Ark. Code Ann. §§ 23-60-101, *et seq.*
2. Respondent was sent a notice of hearing on September 16, 2015, to 2850 Lake Vista Dr., Lewisville, Texas, by certified and first-class mail. (Exhibit 1).
3. Respondent resides in Texas.

4. Mr. Chamizo's Delaware license was revoked for failure to report an adverse criminal action.

CONCLUSIONS OF LAW

1. Ark. Code Ann. § 23-64-512(a)(9) authorizes a insurance producer's license to be revoked for having an insurance producer license revoked in any other state. Respondent's Delaware license revocation is therefore a violation of Ark Code Ann. § 23-64-212(a)(9).

RECOMMENDATION OF HEARING OFFICER

WHEREFORE, upon consideration of the evidence of record and the foregoing Findings of Fact and Conclusions of Law, the Hearing officer recommends the following:

1. That the Arkansas Insurance Non-Resident Producer's license of Respondent Shawn Chamizo be revoked
