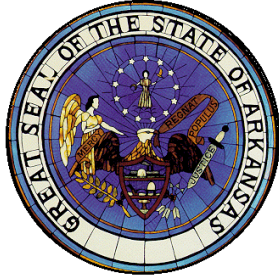

Policy Limit

The policy limit is \$300,000 per occurrence for all claims reported by Arkansas Legislative Audit on or after **July 1, 2015**. A \$2,500 per occurrence deductible will apply.

Cancellation as to any Employee or Official

The cancellation of coverage for an Employee or Official will be made by the Governmental Bonding Board. Contact Risk Management to obtain a list of Employee or Official cancellations.

Certificate of Coverage

A Certificate may be obtained by sending an email request to the Risk Management Division at insurance.risk.management@arkansas.gov
The Certificate of Coverage is your evidence of coverage. Present the certificate when asked for proof of Fidelity Bond coverage.

Claims

All Proof of Loss notices must be submitted to the Arkansas Governmental Bonding Board by Arkansas Legislative Audit. Coverage is provided only for funds audited in compliance with Section 6 of the Bond policy. Independent audits not conducted by Arkansas Legislative Audit must be completed within (18) months of the close of each Participating Governmental Entity's fiscal year.
